- The Medical qualifications possessed by the candidates should have the recognition of the Medical Council of India.
- Completion of compulsory Rotating internship Certificate, [Registration Certificate, an official document showing name of college / institution from where degree /diploma has been done and official document showing name of the institution from where experience has been gained, are required.]
- Every selected doctor shall be required to serve 8 hours per day (including night time) and 5 days in a week, including Saturdays/ Sundays/Holidays as per the duty roster to be prepared by the competent authority from time to time.
- Reservation rules as per Government of India shall be applicable.
- After joining Doctors need to give one month of notice in case of resignation. The institute can terminate the Doctor at its sole discretion.
